



November 9th 2024 1st Benelux-Cup season 2024-2025

The Nijmeegse Schaatsvereniging (NSV) in cooperation with the Koninklijke Nederlandsche Schaatsenrijders Bond (KNSB) has the honour to invite you for the 1st Beneluxcup competition of the season 2024-2025 on 9 November 2024

Location:

“Triavium ijsbaan en evenementen”

Provisional Program:

Skater registration: 07.30h – 08.00h (should a club **only** have riders from categories ABCS, please contact the organising committee for registration)
Warming-up: 08.00h
Start of competition: 08.30h
End of competition: 15.00h

Notice: The final program will be published on www.ShorttrackOnline.info a few days before the start of the competition. Be sure to check this in advance.

Distances:

The distances will be determined based on the number of skaters and the available time.

Entry:

Through the relevant club's competition secretary via www.shorttrackonline.info.
Closing entry: Saturday 2 November 2024.
Benelux competition is open to skaters with a Belgian, Dutch or Luxembourg Licence. Dutch skaters must belong to a club from the Region NBLZ.

Division:

In the program / composition of divisions, the organising committee will take into account the latest developments regarding the Starclass limits, as well as the participation of riders with less experience. The organisers reserve the right to change the composition of the divisions in the interest of safety and / or a good competition.



Start procedure:

For all categories there will be a tolerance of one false start.

Category:

Junior F: born after 30/06/2015

Junior E: born from 1/07/2013 to 30/06/2015

Junior D: born from 1/07/2011 to 30/06/2013

Junior C: born from 1/07/2009 to 30/06/2011

Junior B: born from 1/07/2007 to 30/06/2009

Junior A: born from 1/07/2005 to 30/06/2007

Senior: born from 1/07/1994 to 30/06/2005

Master: born before 1/07/1994*

Awards:

EF: all participants will be awarded with a medal.

Individual classification DEF & ABCS: awards will be given to the first, second and third in the final classification of each category.

Helmet caps:

All skaters need to have helmet caps. A deposit of € 50,- per club will be charged.

We kindly ask you to bring the exact amount in cash in an envelope with the club name and the amount on it. The caps will be handed out before the competition. After the competition the caps need to be returned and the deposit can be retrieved.

Registration fee:

An entry fee of € 30,00 must be paid to the organisers for every athlete. To reduce the amount of cash and fast handling, we ask you to wire the money by bank transfer to organiser bank account no later than Wednesday 6 November 2024

Clubs can only make entries with the approval of their respective ISU Member at: shorttrackonline.info



Track Conditions:

The track is an artificially refrigerated indoor ice surface with the measures of 30 x 60 meters. The protective padding is in accordance with ISU Communication No. 2365. The standard track will be laid out 111.12 meters to the lap with measured curves of 8 meters and there will be 7 markers used to establish the curve. The length of the straight is 28.85 meters. Beside the original track there will be 4 tracks set up to preserve good ice conditions. For all tracks one finish line will be used.

Safety:

The KNSB have issued Safety Regulations applicable to all competitions in The Netherlands

(https://knsb.nl/documents/64/2ccb8a99-shorttrack-communique-2b-baanbeveiliging-st-2023-2024_v25072023.pdf). These regulations will be applicable to all participating skaters in Category C and above. Skaters in Category D-E-F and “Kids on ice” should comply with ISU Communication 1265 (helmet, shin and knee protection, cut-free gloves and neck protection) and applicable Rules such as Rule 291. For more information see: ISU Communication (www.isu.org).

Medical Insurance: It is the sole responsibility of each member, on behalf of its participating clubs, to ensure or provide medical and accident insurance for their athletes. Proof of such can be requested by the Organizing Committee. See ISU Rule 119.

Medical Assistance:

Emergency first aid personnel will be present at the competition. There will be an adequate response time for an ambulance to be on site in case of need.

Liability: In accordance with Rule 119 of the ISU General Regulations, the ISU, the KNSB and the Organizing Committee assume no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection with the competition. Each Member is solely responsible for providing insurance (medical and accident) coverage for their athletes.

Parking: Parking is available around the Triavium Ice Rink. Day tickets (€ 4,40) are available at the reception of Triavium, or payment by bank contact at the exit (€ 1,- per 27 minutes).
