9:00 - 9:45 Check-in teams and registration
10:00 Warming-up
10:30 Start of competition
17:30 End of competition

Notice: The final program will be published on www.shorttrackonline.info, few days before the competition. Be sure to check this in advance.

Distances:

The distances will be determined based on the number of skaters. It is the intention to organise a relay in the categories Jun DEF and ABC Senior/Masters.

Entry:

Through the relevant club's competition secretary via www.shorttrackonline.info

Closing entry: **Monday 9th December, 2024**

In case the event has an unmanageable number of entries the Organisers will follow the rule: first come first served

Start procedure:

For all categories, there will be a tolerance of one false start.

Participants:

- Skaters with a Belgian, Dutch or Luxembourg License
- Dutch skaters must be member of a club from Region NBLZ.

Category:

Junior F - born after 30/06/2015

Junior E - born between 01/07/2013 and 30/06/2015

Junior D - born between 01/07/2011 and 30/06/2013

Junior C - born between 01/07/2009 and 30/06/2011

Junior B - born between 01/07/2007 and 30/06/2009

Junior A - born between 01/07/2005 and 30/06/2007

Senior - born between 01/07/1994 and 30/06/2005

Master - born before 01/07/1994

The organisers reserve the right to compose the divisions in the interest of safety and/or a good competition.

Award:

EF: all participants will be awarded with a medal.

Individual classification DEF & ABCS: awards will be given to the first, second and third in the final classification of each category.

Helmet caps:

All skaters need to have helmet caps.

The caps will be handed out to the team leader/coach.

A fee of **€50 IN CASH** will be asked per club.

We kindly ask you to bring the exact amount in an envelope with the club name and the amount in it.

At the end of the competition the fee will be given back when the caps are returned.

Registration fee:

An entry fee of **€30** per skater must be paid to the organiser.

To reduce the amount of cash and fast handling, we ask you to wire the money by bank transfer to the organiser's bank account no later than **Wednesday 11th December, 2024**.

Use the following format message with the transfer: "Benelux Club X", with the abbreviation of your club on ShorttrackOnline, and X the number of skaters you are paying for. This number should correspond to the number of entered skaters on ShorttrackOnline.

For example: Benelux NSV 5.

Clubs can only make the entries with the approval of their respective ISU member at: shorttrackonline.info.

Track Conditions:

The track is an artificially refrigerated indoor ice surface with the measures of 30 * 60 meters. The protective padding is in accordance with ISU Communication No 2365. The standard track will be laid out 111.12 meters to the lap with measured curves of 8 meters and there will be 7 markers used to establish the curve. The length of the straight is 28.85 meters. Beside the original track there will be 4 tracks set up to preserve good ice conditions. For all tracks one finish line will be used.

Safety:

The KNSB have issued Safety Regulations application to all competitions in the Netherlands. (https://knsb.nl/documents/64/2ccb8a99-shorttrack-communique-2b-baanbeveiliging-st-2023-2024_v25072023.pdf)

These regulations will be applicable to all participating skaters in Category C and above.

Skaters in category D-E-F and „Kids on ice“ should comply with ISU Communication 1265 (helmet, shin and knee protection, cut-free gloves and neck protection) and applicable Rules such as Rule 291.

Medical Insurance:
